**Notice on Viewing of CBT-I (held on and from 05.06.2025 to 24.06.2025) Questions, Responses & Keys and Raising of Objection, if any, to Questions/Options/Keys.**

The Computer Based Test (CBT-I) various posts of Non-Technical Popular Categories (Graduate) against CENNo.05/2024 was conducted **on and from 05.06.2025 to 24.06.2025**. In order to enable candidates who appeared in the CBT-I to view their questions, responses and answer keys, a link has been provided on the websites of RRBs which will be active from **01.07.2025 at 18:00hrs. to 06.07.2025 at 23:55 hrs.**

After viewing the details, objection, if any, regarding the questions, options& keys, can be raised by the candidates for which the time schedule, fee and procedure is given below:

**2. FEE FOR RAISING OBJECTIONS:**

The prescribed fee for raising **objection is Rs.50/-plus applicable Bank Service Charges per question**. In case the objection raised is found to be correct, the fee paid against such valid objections shall be refunded to the candidate after deduction of applicable Bank Charges. The refund will be made to the account from where the candidate has made the online payment.

**3. MODE OF PAYMENT OF FEE:**

**4. PROCEDURE FOR RAISING OBJECTIONS:**

The detailed procedure with necessary guidelines will be available in the link provided on the official website of RRBs.

- Candidates are advised to raise objection, if any, well before the last date and time i.e., **06.07.2025 at 23:55 hrs.** after which no representation from the candidates on the questions, options, keys etc. will be entertained.
- The decision of RRBs on the objections raised shall be final and binding and no further correspondence shall be entertained from the candidates in the matter.
